



VDEI Educational Interpreter Virtual Hub (EIVH) Discussion Protocols

<u>Purpose</u>

Within the Educational Interpreter Virtual Hub a **Discussion Page** is provided by the Department of Education and Training (DET) to enable connection between Educational Interpreters (EI) across Victoria. The Discussion Page is a safe space to allow EIs to:

- Engage in professional conversations on topics and subjects relevant to the EI role
- Provide advice and guidance to colleagues
- Share relevant El resources
- Be connected to a supportive community of practice

<u>Access</u>

- 1. The Discussion Page is available to those who have access to the Educational Interpreter Virtual Hub.
- 2. Participants who fail to abide by the following protocols may be prohibited from accessing the Discussion Page.

General

- 3. No discussion of specific schools, students or staff details are permitted. Always aim to keep information general to avoid breaching confidentiality.
- 4. Posts are required to be professional and courteous. Please respect the diversity of the EI role in schools, including the breadth and range of knowledge and experience of your peers.
- 5. The Discussion Page is a self-regulating environment. Individuals are responsible for their own posts and DET takes no responsibility for posts made by members.
- 6. While it is expected that individuals may express divergent views, it is important to ensure that conversations always remain respectful.
- 7. Discussions will be monitored from time to time by a VDEI Virtual Hub facilitator and the VDEI digital professional learning team.
- 8. If there are concerns that a post has breached protocols, please email VDEI: *vdei@education.vic.gov.au* and the team will follow up appropriately.
- 9. Inappropriate posts will be removed at the discretion of VDEI and a warning issued to the individual. Should inappropriate posts continue, the individual may be removed from the EIVH.
- 10. VDEI reserves the right to remove discussion threads and individual posts if they are deemed to be in breach of ethical guidelines, are inflammatory in nature, or otherwise objectionable.
- 11. The Discussion Page must not be used for any purpose that is unlawful or prohibited by the protocols.
- 12. This is not a forum for self-promotion, spam or for posting irrelevant links.

13. Participants must <u>not post</u>:

- Content that is offensive, indecent or objectionable in any way
- Content that is defamatory or overly critical of individuals or services and organisations which provide help to others
- Content that is likely to cause harm/distress to other people reading the post
- Any content that the sender does not have the right to transmit under any contractual relationship (such as confidential information or personal information)
- Any material that contains software viruses or any other computer programs designed to interrupt, destroy or limit the functionality of any computer or hardware or telecommunications equipment, and
- Links to websites unrelated to the role of Educational Interpreting, Deaf Education, Deaf community or Education in general.
